As stated by the DFC, the project involves approximately \$6 billion of new investment by Apache Corporation during the period 2013-2019 for further exploration, development and production of oil and natural gas in 23 concessions in Egypt.

### **Early Warning System Project Analysis**

The DFC stated that the project is screened as Category A because it involves large-scale onshore oil and gas development.

Egyptian law only requires community consultations for Greenfield projects and major expansions of existing projects. Because the project involves existing assets, no formal community consultation was undertaken.
