Geotérmica Platanares, S.A. de C.V. will develop, construct, and operate a 35 MW geothermal power plant that will provide continuous baseload power to the grid in Western Honduras. The Project will increase reliable electricity generation capacity in Honduras by approximately 2% at a cost that is 24.5% less than the average cost of residential electricity in Honduras. In addition, the Project will be situated in an area of Honduras with little existing generation capacity and significant problems with blackouts.
