### **Project Description**

This Project is expected to have a highly developmental impact on Brazil through the issuance of loans to SME borrowers in the host country. The Bank will focus this funding on lending to women, with a portion of funding dedicated to women-owned and women-led clients, as well as a portion allotted for the underdeveloped states of the country's north and northeast. The SME financing gap in Brazil is an estimated \$483 billion. Additionally, though the country is classified as an upper-middle-income country by the World Bank, Brazil struggles with income inequality. The country's GINI coefficient at 53.9 is of one the highest in the world, and the income disparity between the south and north is pronounced.
