

Project Description

A corporate loan of up to \$100 million (the "Loan") that will be lent to CABEI to fund financial institution intermediaries in Honduras, El Salvador and Guatemala, which will then lend to micro, small and medium enterprises("MSMEs") in response to the COVID-19 pandemic (the "Project"). The Loan is part of a larger estimated \$365+ million fund-raising to help support COVID-19 affected MSMEs.

Investment Description

• US International Development Finance Corporation (DFC)

A \$100 million 10-year door-to-doorloan with a two-year principal grace period before level-payment amortization.

Financial Intermediary

Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.

ACCESS TO INFORMATION

Unlike many other development finance institutions, DFC does not currently have an access to information policy.

Under the United States Freedom of Information Act (FOIA), DFC is obliged to respond to reasonably formulated requests for Agency records.
