### **Project Description**

Produbanco will use the DFC loan proceeds to expand its women borrowers and small-and-medium enterprise ("SME") loan portfolio. Of the loan proceeds (i) at least 30% will be for 2X loans, (ii) at least 20% for green lending, and (iii) the remaining 50% for other SME loans. The Loan will also provide much-needed liquidity to support these portfolios in the wake of the COVID-19 pandemic.
