According to the DFC website:

DFC will provide a direct loan of up to \$37,500,000 to Global Partnerships Impact-First Growth Fund, LLC (the "Borrower"). The funds will be used to support highly impactful social enterprises that expand opportunity for people living in poverty by providing basic products or services in the targeted areas of livelihoods, education,

energy, health, housing, water, and sanitation (the "Project"). At the onset, the Borrower will prioritize social enterprises who, given the COVID-19 pandemic, require infusions of patient debt on attractive terms to resume growth and scale impact.

Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.
