### **Project Description**

The expansion of Coopac's lending to small and medium-sized enterprises ("SMEs") in Peru. The Project is expected to have a developmental impact on the economy of Peru through the provision of financial services to SMEs, with a portion of funding dedicated to women-owned and women-led enterprises. SMEs contribute substantially to the Peruvian economy, but only 35% of SMEs operating in the country have borrowed from a formal financial institution. The Peruvian government is actively seeking ways to bring SMEs into the formal economy, with a goal of raising the proportion of SMEs with formal loans to 60% in order to spur economic growth. 1 Coopac's model for SME lending is well-aligned with Peru's national strategy for economic development.
