According to the bank website:

The technical assistance will support Gazelle Fund LP's (the "Fund") Ukraine to Caucasus Bridge Technical Assistance Facility ("Facility"), which will support companies relocating from Ukraine to Georgia or Armenia. The Facility will provide technical assistance using three tools: grants, direct technical assistance, and zero percent interest loans. By supporting the Facility, DFC will increase the developmental impact of its existing loan to the Fund while providing support for Ukrainian refugees.
