#### **Project Description**

A direct loan for the expansion of affordable optical care services to underserved populations in Mexico (the "Project"). The Project is expected to have a highly developmental impact in Mexico through support for a retail eye care business, with a focus on targeting underserved customers. Access to eyeglasses is a major issue in Mexico, with an estimated two-thirds of Mexicans experiencing significant vision difficulties that would be solved by wearing glasses. The Borrower represents that over half of its customers are unaware of or unable to address their visual impairment, with two-thirds of its customers are from low- or middle-income households. Through DFC support, the Borrower will significantly expand its innovative business model to reach hundreds of thousands of new customers. In addition, the Borrower will significantly expand its workforce, threequarters of which is currently made up of women.
