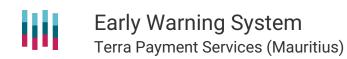

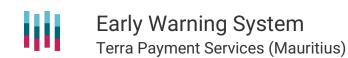

The Borrower says it wants to achieve global financial inclusion by making it possible to send money through any payment method, no matter where its partners operate, or customers reside. To do this, the Borrower aims to create formal remittance channels in underserved markets where such channels are non-existent or dominated by cash.

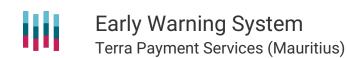
Unlike many other development finance institutions, DFC does not currently have an access to information policy.
