## Project Description

As stated by the DFC, African Infrastructure Investment Fund 4 will make equity investments in infrastructure projects and in companies operating in the infrastructure sector in Africa. Target sectors include logistics, transportation, energy transition, and digital infrastructure.

Substantial demand for greater infrastructure capacity in Africa has created a need for investment in African Infrastructure Investment Fund 4's target sectors. Africa is a priority region for the USG, and DFC support for African Infrastructure Investment Fund 4 will provide much-needed capital to infrastructure projects that will catalyze economic growth.

The financial intermediary, African Infrastructure Investment Fund 4, is a South African US\$-denominated *en commandite* partnership.

Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.
