## Project Description

As stated by the DFC, the project consists of a \$150 million Basel III-compliant Tier 2 bond to expand the Borrower's on-lending to women and women-led small and medium enterprises, including in Turkey's least developed regions.

The Project is expected to have a positive development impact in Turkey by helping to address the country's small and medium enterprise ("SME") financing gap, which is estimated to be approximately \$80 billion, or 11% of GDP. More specifically, the Project will seek to improve the livelihoods of women by allocating 100% of project proceeds to improve access to finance to both individual women and women-led/women-owned SMEs. Additionally, the Project will address the ever-present lack of financial service penetration in rural areas by allocating 50% of the project proceeds to women and women-led/women-owned SMEs in the country's least developed regions, including provinces in southern and eastern Turkey.
