#### **Project Description**

Early Warning System

As stated by the DFC, the Limanska Wind Farm Technical Assistance ("TA") consists of the development, construction, and operation of a 159 MW wind power farm, with turbines located on 21 plots of land in Ukraine's Odesa region near the Black Sea coast. The TA is expected to generate 527 GWh of electricity per year.

The Project sites are located approximately 35 kilometers northeast of the City of Odesa, in the southwestern part of Ukraine. TA support for the Project aligns with DFC's Roadmap for Impact priority of expanding access to competitive, sustainable, and reliable electricity and promoting energy security and diversification.

In addition, the TA will help DFC meet its Climate Action Facility goal of committing at least \$50 million in TA funding over five years to support the identification, design, and implementation of DFC's climate portfolio.
