#### **Project Description**

As stated by the DFC, Evolution III LP invests in climate-focused clean energy infrastructure, energy access, and resource efficiency growth investments in Africa.

EVIII seeks to have a positive development impact in Africa by providing much-needed capital to infrastructure-type renewable energy platforms and projects, as well as technology-based solutions aimed at affordable energy access and resource efficiency for households and businesses. Predominantly focused on lower-middle- income countries, EVIII will seek investment opportunities across a range of climate projects, including utility, commercial and industrial, and residential renewable energy, clean cook stoves, e-mobility, and smart meters.

#### **Financial Intermediary**

Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.

As stated by the DFC, Inspired Evolution Managers Limited is a private company incorporated in accordance with the laws of Mauritius. Evolution III (the "Fund") is an Africa Regional Fund that offers next-generation energy transition investment strategies and will look to invest in traditional utility-scale, grid-connected IPP platforms and projects, decentralized commercial and industrial (C&I) private offtake opportunities, off-grid solutions and energy-as-a-service (EaaS) micro-grid infrastructure-type offerings. It will also look to invest growth equity into energy and resource efficiency, technology-based businesses that "do more with less" and reduce resource footprints.
