### **Project Description**

According to bank provided project information, this direct Technical Assistance Grant will support the development and structuring of a pilot cohort of three catalytic financing vehicles that support financial inclusion at scale. DFC's contribution will support the launch of two funds-of-funds (Ghana, Nigeria) and a credit-risk guarantee facility in partnership with the Central Bank (Zambia), preparing them for potential DFC investment. The TA grant will co-fund a broad menu of services that include market and feasibility studies; financial and legal structuring; outreach and marketing; impact measurement and management; capacity building; and learning and knowledge dissemination.
