#### **Project Description**

According to the Bank's website, the project consists of a senior loan to a debt vehicle created to invest first loss capital into Women's Livelihood Bonds in order to catalyze investors into the bond issuances, the proceeds of which fund loans to entities that support women's lives and livelihoods and climate resilience.



#### **Early Warning System Project Analysis**

DFC direct investments into Financial Intermediaries to support their investments into bonds are screened as Financial Intermediary - C for environmental and social assessment. These downstream investments are expected to result in minimal adverse environmental and social impacts. Therefore, all those downstream investments have been pre-screened as low risk and further review and consent is not required for these investments.
