Project Description

According to the Bank's website, the project consists of a ten-year, 80% coverage Loan Portfolio Guaranty ("LPG") to support bank lending to micro-, small-, and medium-sized enterprises ("MSMEs") in seven oblasts of western Ukraine. At least 20% of the loans under DFC coverage must be made to small businesses operating across the agricultural value chain in Ukraine.



Early Warning System Project Analysis

DFC loan portfolio guaranties to financial institutions in support of MSME lending are screened as a Financial Intermediary C (FI-C) for environmental and social assessment. These downstream investments are expected to result in minimal adverse environmental and social impacts. Therefore, all those downstream investments have been pre-screened as low risk and further review and consent is not required for these investments.

Financial Intermediary

Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.
