## Project Description

According to the bank, the DFC has provided Nilus with a \$5.2 million direct loan that will support the operational and capital expenses needed for Nilus to breakeven in Mexico City and expand to a new market. The post-investment technical assistance of \$330,000 will be carried out over twenty-four (24) months in Mexico City and split into three components – creating community leader trainings for women community leaders; developing enhanced impact measurement tools; and enhancing corporate governance practices – all of which will strengthen the developmental impact of DFC’s debt investment. As a result of the TA, Nilus will be able to operate more effectively, reaching more endcustomers who are food insecure and expanding access to affordable, healthy food in Mexico City.
