As stated on the project disclosure document, the proceeds of the Loan will be used by the Borrower to finance the purchase of containerized solar generation systems and battery energy storage systems (“Containerized Solar Mini-Grids”) designed and assembled in South Africa by Sustainable Solar Systems, a subsidiary of the Sustainable Energy Group. The Borrower will provide short term vendor financing to decentralized clean energy developers across Sub Saharan Africa to facilitate their purchase of the Containerized Solar Mini-Grids.
