## Project Description

As stated by the DFC, Trinity Metals is the largest mining company in Rwanda and operates three mining complexes near the city of Kigali: Rutongo Mines (tin), Nyakabingo Mine (tungsten), and Musha Mines (tin, tungsten, tantalum, and lithium). They are deeply committed to incorporating responsible mining practices.

To support that goal, the Direct Technical Assistance Grant will focus on a) identifying and assessing existing E&S impacts and historical mine legacy issues and developing management plans and programs to address them b) enhance skills development and meet training needs in critical areas of the operation to support mine expansion and transformation. c) will be used to accelerate the implementation of an IFC Performance Standard-compliant and ISO-standard integrated Safety Health Environment & Community (“SHEC”) Management System.

## People Affected By This Project

Trinity Metals' mining operations in Rwanda have had severe environmental, social, and human rights impacts, including forced displacements, land grabs, and inadequate compensation for communities near Rutongo, Nyakabingo, and Musha mines. Water pollution, deforestation, and toxic waste dumping have degraded farmland and caused health crises, while worker exploitation, child labor, and deadly safety violations persist in its supply chain.

Nyakabingo Mine: Farmers have raised concerns over loss of agricultural land,.
