The Project is expected to have a positive development impact in El Salvador by addressing the country's small and medium enterprise as well as microenterprise ("MSME") financing gap country wide, which is estimated to be approximately \$2.1 billion or 8% of GDP. Fedecredito's business model as a cooperative allows the Borrower to reach MSMEs and lower-income borrowers through its broad network as well as interact, understand, and assess these borrowers' needs. Additionally, the Project seeks to support womenowned or -led enterprises in the country that have historically faced constraints in accessing financial services
