### **Project Description**

As stated by the DFC, the project will support the design, construction, and operation of a 120 MW wind power project in Mozambique.

The Project, a 120 MW onshore wind project in Namaacha, is expected to have a positive development impact in Mozambique by fueling the government's plan to introduce 2,300 MW of new installed capacity and to add five million on- and off-grid connections by 2030. As the first utility-scale wind farm in the country, the Project is expected to produce 382 GWh of renewable energy per year.
