Project Description

Prodigy Finance Limited, a company incorporated under the laws of England and Wales ("Prodigy"), will originate, underwrite and service (i) eligible graduate school student loans for students from DFC-eligible countries to obtain graduate degrees from top universities globally and (ii) \$5,000,000 of eligible student loans for students attending top coding academies globally. Those loans will be sold by Prodigy to the borrower, a special purpose vehicle (the "SPV") domiciled in Ireland.

This transaction is a \$200 million increase to a \$50 million loan that was approved by OPIC in 2019. The SPV will use the proceeds of the aggregate \$250 million senior DFC loan (the "DFC Loan") and subordinated loans to purchase and fund the student loans (the "Project").
