Project Description

According to the DFC, the Project involves the mining of uranium at a site which is located near Agadaz in Niger. The surrounding area is sparsely inhabited with no permanent villages within the project's direct (i.e., 7 km) area of influence. Livestock grazing occurs to a limited extent within the area. The extended (i.e., 15 km) area of influence includes three permanent villages and more extensive livelihood activities.

The DASA Uranium Project is fully permitted for underground mining and construction of supporting infrastructure. Underground mine development and construction of surface infrastructure are currently underway, commercial production is scheduled to begin in early 2025.
