Project Description

The proposed Project involves the design, construction, operation and maintenance of a 150 MW geothermal power plant. The Project will be implemented in two phases with a first phase of 50 MW capacity, followed by 100 MW developed over a period of five years. The proposed DFC-supported Project will cover phase 1 only. The exact locations of wells, additional well pads, pipelines and the power plant will be confirmed in the detailed design phase of the Project, following exploration drilling. In addition to the power plant, the Project will include exploration and production drilling, establishment of well pads, access roads, water supply, quarries and a collection pipeline system. The Project will also require construction of a transmission line to connect the Project with the national grid; the design and route alignment of the transmission line are currently being finalized by Ethiopia Electric Power (EEP).
