The SME Competitiveness Support Programme in Serbia ("the Programme") aims to strengthen the competitiveness of SMEs in national, regional and international markets by incentivising them to undertake investments necessary to increase their productivity and competitiveness, to improve their production capacities and enhance processes and product quality through the introduction of the EU standards in the field of environmental protection, product safety, product quality and occupational health and safety. These improvements will boost the overall competitiveness of SMEs within both the national and regional economy along with the EU internal market. The Programme comprises EBRD credit lines to financial intermediaries in Serbia for on-lending to SMEs supported by the EU-funded incentives to SMEs and technical assistance for Programme implementation. The Programme is expected to finance a significant amount of green economy technologies that will be accounted as part of the overall results.

The objectives of the "Serbia EU/EBRD SME Competitiveness Support Programme - Evaluation Study and Capacity Building" technical cooperation project are to:

1. Establish whether the investments supported by the Programme led to an increase in the competitiveness of the SMEs that have benefited from it; 2. Provide recommendations on how similar programmes could be deployed in the future and how local stakeholders could ultimately continue the implementation of this product beyond the EU support; 3. Ensure sustainability of the Programme and transfer of know-how; further dissemination of best practices to a wider group, provide local capacity-building to organisations which could in the medium term implement a government-supported programme of similar nature or objectives.
