### Project Description

According to the bank website, the Government of Greece is currently considering a project as a Public-Private Partnership ("PPP") to utilise water and surface runoffs into a dam accompanied by the appropriate irrigation network for serving agricultural needs of the area which falls within the remit of the Municipalities of Pylou Nestoros and Messini. More specifically, the Project includes:

- The elaboration of the design of water mains of Lachanada and Militsa villages, as well as any supporting designs during the construction phase.
- The construction:
  - of the Minagiotiko dam;
  - of the irrigation network for the irrigation of an area of 35.000.000 m<sup>2</sup>;
  - of the accompanying roadworks:
    - restoration of parts of existing rural roads that are going to be flooded;
    - roads for access to the dam site, the main pumping station and around of the reservoir; and
    - small sections for the access along water ducts.
  - of the accompanying quarries and depot areas with the necessary accesses;
  - of the water mains of Lachanada and Militsa.
- The implementation of an Information Management System and remote control.
- The maintenance and operation of the irrigation network for up to 21 years.
