### Project Description

According to the bank website, the project consists of educational facilities and associated facilities located in different land plots within the City of Kozani owned by the Municipality.

The facilities include: a) Schools: Technical Lyceum; Primary School; Two Nursery Schools; and an Art High School; b) Athletic Facilities; and c) a Science and Technology Laboratory Centre.

The Project is located 4.5 km west from the city of Kozani in an urban area (FEK 138/D/8-3-1989) under development by the city. The Zone itself covers an area of 550 acres and it is 3km away from Egnatia Highway Road with easy access from all destinations and urban centers around Kozani. The Zone is also adjacent to a 950 acres area where the West Macedonia University Campus is planned to be located in approximately four years' time. .

The Project includes:

- Design and build of the Project according to the technical, safety, environmental and social specifications within a two-year period.
- Successfully complete trial operation and commissioning tests.
- Conduct routine and heavy maintenance and technical management (preventive, corrective, repair, replacement), day-to-day technical operation and supervision of availability of the Project;
- Prepare a forward investment plan for the Project (to prepare for future asset renewal or service life extension).
