As stated by the EBRD, the proposed project consists of a sovereign loan of up to EUR 30 million to the Government of Moldova to co-finance the rehabilitation of approximately 200 km of main road sections located on Moldova's north-south and east-west road axes. The Project will also support reform of road sector financing and institutional strengthening aimed at improving the capacity of the State Road Administration to manage and maintain the road network under its responsibility effectively and efficiently.
