#### **Project Description**

According to EBRD website, the project will be providing a sovereign loan to be on-lent to the Bishkek City for the benefit of the Bishkek Street Lighting Company BishkekSvet, a municipal company responsible for street lighting management in Bishkek. The Company is wholly owned by the City of Bishkek.

The Project will finance modernization of the street lighting infrastructure through the following components:

- 1. installation of modern street control and monitoring system;
- 2. partial rehabilitation of the street lighting infrastructure; and
- 3. installation of light-emitting diodes (LED) luminaries.

Further, it aims at reducing the operating cost of the street lighting system in the City through the introduction of modern energy efficient technologies. The Project will not only modernise the infrastructure and secure better service provision, but also introduce better contractual arrangements to run the system.

For the technical cooperation, the assignments are feasibility study; restatement and audit services; financial and operational performance improvement programme and; project implementation support.
