Project Description

This project involves a senior loan of up to EUR50 million to BZ WBK Leasing S.A. ("Project") under the GEFF Framework in Poland for Leasing ("Framework"). The proceeds will be used to provide leasing finance to small and medium-sized enterprises ("SMEs") in Poland. This will be the first project under the Framework.
