Tumad was established in 1989 originally to supply construction materials (i.e. aggregate, concrete and plastering) for the Sponsor's construction business. Between 2012 and 2014, Tumad expanded into the metals mining sector by acquiring several mineral exploration licences in Balıkesir, the Black Sea region, Gumushane and Ankara. Earlier this year Tumad divested its construction materials business and has focused entirely on the metals mining.
