## Project Description

According to the Bank's website, the project will provide funding to the Public Enterprise for State Roads to finance the construction of a 10.7 km long section of new motorway running from Bukojchani to Kichevo.

The main risks of the project relate to potential impacts to local water quality, habitats and biodiversity, nuisances caused to the local population during construction and possible impacts to local community and their livelihood associated with land acquisition.
