Project Description

PROJECT DESCRIPTION

EBRD is providing of a 15-year sovereign-guaranteed loan of up to US\$ 5.0 million (EUR4.5 million) to the State Unitary Enterprise Dushanbe District Heating Company. The loan will consist of two tranches: Tranche I and Tranche II of up to US\$ 2.5 million each. The EBRD loan is expected to be co-financed by a US\$ 5 million grant from the EBRD's Shareholders Special Fund. The total project cost is 10 million USD.

PROJECT OBJECTIVES

The Bank's first district heating sector project in Tajikistan will include:

- (i) the rehabilitation of selected sections and potentially the expansion the district heating ("DH") network;
- (ii) the rehabilitation of pumping stations and the introduction of metering at pumping stations and pilot metering at apartment level;
- (iii) the procurement of operational and maintenance machinery and equipment. The Project is proposed as a 'trigger' project for Dushanbe (the "City") under the Green City Framework 2 ("GrCF2").
