## Project Description

According to the Bank's website, the EBRD invested in July 2018 EUR 40 million in a 4-year EUR 400 million Eurobond issued by OTE PLC under OTE PLC guaranteed by Hellenic Telecommunications Organisation SA ("OTE") Global Medium-Term Note ("GMTN") programme. The bond was repaid in July 2022.

The proceeds of EBRD's investment have been used to finance sustainability upgrades and renovations aiming to improve the energy footprint of OTE's real estate portfolio in Greece.

## Early Warning System Project Analysis

Categorised C (2014 ESP). The OTE Group is accredited with ISO 14001, OHSAS 18001 and ISO50001. The OTE Group has corporate fair employee policy in accordance with legal requirements of Greece and the EU as well as the UN Global compact. The Bank continued to monitor the Client's PR compliance by reviewing the annual environmental and social reports.
