## Project Description

According to the Bank's website, this project finances the expansion of a 202km road in the north of Mongolia from Ulaanbaatar to Darkhan, the country's second-largest city.

The project will include: construction of a new 2-lane road, including roundabouts, U-turns and stopping areas; provision of road furniture; construction of crossings over eight railways; construction and rehabilitation of bridges and culverts; and rehabilitation of toll booths.

According to the bank, the main potential impacts during construction and operation will be associated with air quality as a result of dust and gaseous emissions, noise and vibration, disturbance and loss of soils, consumption of materials and waste generation, land take and economic displacement, construction and public health and safety, management of the workforce, road and traffic safety and some impacts on cultural heritage.
