Project Description

According to bank documents, the investment involves provision of a sovereign loan of up to EUR 150 million in favour of the Kingdom of Morocco to co-finance:

- 1. the construction of key components of the Saiss water transfer network comprised of the main distribution pipeline as well as the primary and secondary distribution networks; and
- 2. the rehabilitation and modernisation of the water distribution network and full conversion to drip-fed watering system in the Garet perimeter.

The Saiss II component is part of a staged programme to preserve the Saiss aquifer and promote sustainable water management within the Saiss plain. As part of this programme, the Bank has approved a sovereign loan of up to EUR 120 million and mobilized grant financing of EUR 30 million from the Green Climate Fund (GCF) to finance the construction of a 135 km (a 45 km section of the main transfer pipeline with a total length of 62 km outside the Saiss plain and a 90 km main distribution pipeline within the Saiss plain) water transfer pipeline from the M'Dez dam to the boundary of the Saiss perimeter.


