The EBRD Project Summary said that the senior loans totaling may be allocated to the state-owned companies Intergas Central Asia JSC (ICA) and KazTransGas Aimak JSC (KTGA). These two companies are EBRD's long-standing clients and fully owned subsidiaries of KazTransGas JSC.

The report also said that through the project, the EBRD is looking to help the subsidiaries of KazTransGas optimize the balance sheet, continue energy efficiency improvements and develop a Corporate Governance Action Plan.
