The loan proceeds will be on-lent to the city of Talas for the benefit of the Talas water company. The loan will be cofinanced by a EUR 3.6 million investment grant from an international donor or the EBRD Shareholder Special Fund.

The Sub-project will finance critical wastewater infrastructure improvements in the city of Talas, including construction and rehabilitation of wastewater networks and construction of the wastewater treatment plant.
