OSMANGAZI ELEKTRİK DAĞITIM AŞ (OEDAS) is owned by Zorlu Osmangazi, a company founded by Zorlu Holding A.S. as a 100 per cent subsidiary of Zorlu Enerji. OEDAS is the incumbent for the distribution of electricity in the Osmangazi region which includes five provinces covering a c. 49,344 km<sup>2</sup> area, Afyonkarahisar, Bilecik, Eskisehir, Kutahya and Usak, with a total population of around 2.79 million people. The company has circa 50,787 km of distribution lines and c. 7,855MVA of transformer installed capacity.
