## **Project Description**

According to bank provided information, the project involves the provision of up to USD 26,250,000 (Equivalent to EUR 24,760,000 as of 26/04/2022) unsecured loan under the GCF GEFF Regional - Morocco II framework to Banque Centrale Populaire ("BCP"), of which up to USD 25,000,000 in EUR equivalent to be provided by EBRD and up to USD 1,250,000 by the Green Climate Fund ("GCF") under the GCF-Green Economy Financing Facility ("GEFF") Regional Framework. The proceeds of the loan will be used for financing investments in climate change mitigation and adaptation technologies.

The project will facilitate a green economy transition in Morocco by on-lending to private sector sub-borrowers to implement green investments in energy efficiency, renewable energy and climate resilience measures.
