## Project Description

As stated by the EBRD, the project consists of the provision of a senior secured loan of up to US\$ 22 million equivalent (in US\$ and KZT) to Energo Trust LLP, SPV incorporated in Kazakhstan, for the development, construction, and operation of a wind power plant with an installed capacity of 50 MW in the Arshaly district of Akmola region, Kazakhstan. The Bank's loan will be utilised to cover the historical project costs.

The project will support Kazakhstan in its objective to increase the share of renewable energy in the energy mix, contribute to reducing Kazakhstan's carbon intensity, and address the country's increasing electricity demand.

The main construction and delivery of all 10 wind turbines has now been completed. The Client used the wind turbine generators manufactured by Windey Energy Technology Group Co Ltd, China-based company.
