According to the Bank's website, the project consists of the provision of a loan in the amount of up to EUR 14.2 million to Braila water company ("CUP Dunarea Braila"), the regional water operator in Braila County, Romania. The proceeds of the Bank's investment will be used to co-finance, alongside EU funds, water and wastewater investments under the relevant EU Infrastructure Programme ("EU Programme") in Romania.

The Project will enable CUP Dunarea Braila to: (i) extend its water and wastewater network and services in the region; and (ii) meet compliance with the relevant EU water and wastewater standards in the Project area.
