## Project Description

EBRD had provided a loan of up to EUR25 million to SIJ Acroni d.o.o. and SIJ Metal Ravne d.o.o., the fully owned subsidiaries of Slovenska Industrija Jekla d.d. ("Slovenian Steel Group", "SIJ" or the "Company"). The Bank's financing was part of an upto EUR230 million, long term debt facility.

SIJ operates two electric arc furnace steel plants, namely SIJ Acroni and SIJ Metal Ravne that are responsible for the Company's flat and long steel products respectively.

The Project contributed to the Company's energy efficiency, investment programme.

EBRD had provided up to EUR 25 million senior loan with the proceeds to be used to finance energy efficiency improvement capex investments.
