Project Description

As stated by the EBRD, the project consists of the provision of a 3-year senior loan in the amount of up to US\$ 2 million (in Kazakhstan tenge equivalent) to a Kazakh private leasing company TechnoLeasing LLC under the Financial Intermediaries Framework.

The financing will be used by TechnoLeasing LLC to finance assets to be leased to local private micro, small and medium enterprises in Kazakhstan.

The project will also help to diversify TechnoLeasing's funding base. The project aims to ensure prudent lending practices as the Company will be required to maintain the portfolio quality at an acceptable level.

A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares.
