### Project Description

According to the bank website, the project consists of a senior secured loan of up to US\$ 28m to Yildirim Albanian Mining Investments Sh.p.k. and Albchrome Sh.p.k. for the purpose of the acquisition of Albchrome Holding Sh.p.k. by Yildirim Holding A.S.. The loan will consist of two facilities: Facility A of up to US\$ 8,400,000 will be provided to refinance the debt of Albchrome outstanding at the date of the acquisition, and Facility B of up to US\$ 19,600,000 will be to partially refinance the Group's funding of advance for the acquisition.
