The proceeds of the loan will be used for financing investments in climate change mitigation and adaptation technologies by local private sector commercial sub-borrowers in a gender-responsive way in line with the standards and reporting requirements for the GEFF in Armenia. 100 per cent of the loan proceeds will be related to Green Economy Transition investments.
