### Project Description

According to the EBRD, the project consists of a loan of up to EUR 18 million to Compania de Apa Târgoviște-Dambovită, the regional water operator in Dambovită County and neighbouring localities. The proceeds of the loan will be used to co-finance, alongside EU Cohesion Funds, an extension and modernisation of the company's water and wastewater infrastructure and services. The EU investment grants are being made available under the EU Large Infrastructure Operational Programme approved in 2021.
