## Project Description

According to the Bank's website, the KyrSEFF III is envisaged to provide up to US\$ 50 million to qualifying participating financial institutions (PFIs) with the objective to on-lending to GET-eligible green investments in the commercial and residential sectors of Kyrgyz Republic, with the addition of operating in a gender-responsive way. The Facility is expected to be supported with grant funds from the Shareholder Special Fund (SSF) and potentially other donors. The grant funds will fund Technical Cooperation (TC) to be provided to PFIs and sub-borrowers and Investment Incentives to sub-borrowers.
