## Project Description

According to the Bank's website, the project consists of a senior secured A/B loan of up to USD 230 million, USD 130 million of which is to be provided by the Bank, with 7-year tenor to Borusan EnBW Enerji Yatirimlari ve Uretim A.S., a corporation incorporated in Turkiye. The proceeds of the Loan will be used in the reprofiling of the existing debt balance of the Borrower (and its subsidiaries in the renewable energy portfolio) amounting to USD 350 million to be provided together with commercial banks as parallel lenders. The Project will be carried out in connection with a corporate reorganization of the Borrower and subsidiaries, which will result in the merger of its renewable energy portfolio under the Borrower as a single entity. The Project will improve the balance sheet of the Company to enable the development of new renewable energy investments, supporting the Borrowers ambitious expansion plans.

The project has been categorised B (2019 ESP) due to the nature of the Company's operations, including various wind power plants and a hydropower plant in addition to a pipeline of new renewable projects, including solar PV.
